Executive Summary

Introduction & Background


The Charles County Local Management Board, on behalf of the tri-county Southern Maryland region of Calvert, Charles and St. Mary's counties, is a recipient of a System of Care (SOC) Expansion and Sustainability Cooperative Agreement from the Substance Abuse and Mental Health Services Administration (SAMHSA). The federal grant, known as Building Resiliency from Infancy through Development, Growth and Empowerment (BRIDGE) is supporting cross-system efforts to strengthen Southern Maryland's early childhood SOC through developing, financing and implementing evidence-based services for children from birth through age five with behavioral health challenges and their families and caregivers. The Institute for Innovation & Implementation (The Institute) prepared a September 2017 Southern Maryland BRIDGE Finance Plan. With support from SAMHSA, The Institute contracted to conduct a Southern Maryland cradle to career and behavioral health fund mapping project for Fiscal Years (FYs) 2013, 2015 and 2017. To supplement the Southern Maryland BRIDGE Finance Plan, David McNear, a fiscal mapping consultant, researched and prepared the fund maps, with cooperation and consultation from The Institute and the SOC grant partners. The project includes a behavioral health fund map, or a review of public investments in children and youth in the tri-county region with behavioral health issues, an early childhood fund map, with an inventory of regional early childhood investments, and a cradle to career fund map, or a fiscal survey of public spending on Southern Maryland children, youth and families.

Key Findings of the Behavioral Health Fund Map


Behavioral health fund map investments, along with cradle to career spending, increased through the survey period, going from \$51.1 million in Fiscal Year (FY) 2013 to \$60.9 million in FY 2017, an increase of \$9.8 million, or 19.1%. Spending reported in the behavioral health fund map grew from 4.4% of total cradle to career investments in FY 2013 and FY 2015 to 4.9% of total spending in FY 2017. As spending increased, new investments were reported in FY 2017 in youth mentoring and tutoring (\$2.8 million), outpatient psychiatric acute care (\$2 million) and early childhood mental health (\$944,035); and spending on transition-aged youth services increased by \$589,018. Cradle to career spending grew by \$81.4 million, or 7%, from \$1.17 billion in FY 2013 to \$1.25 billion in FY 2017.

Behavioral health fund map spending per child under age 18 increased from \$576 in FY 2013 to \$696 in FY 2017, going up \$121 (with rounding), or 20.9% through the survey period.



More than four-fifths of services paid for in the behavioral health fund map are delivered either in the home/community or are school-based, with about one-fifth of investments supporting services in institutional settings, e.g., juvenile detention or inpatient hospital charges. Throughout the fund map survey period, home/community-based services jumped by 49.8%, or \$8.5 million, driven by a \$2 million increase in outpatient behavioral health hospital charges and the accounting for a \$2.8 million federal 21st Century Community Learning Centers grant to ACF Scholarship Foundation for mentoring and tutoring and the BRIDGE grant funding in FY 2017. School-based services increased \$2.2 million, or 9%; while spending on institutional settings dropped by \$889,577, or 9.2%.



Opportunities to Supplement Fiscal Strategies in BRIDGE Finance Plan

2018 state legislation established the Behavioral Health Crisis Response Grant Program to provide related funding to local jurisdictions. Beginning in FY 2020, or the next budget submitted, the administration is required to fund the program at \$3 million, with mandated spending increasing to \$4 million in FY 2021 and \$5 million in FY 2022.

The Maryland Safe to Learn Act of 2018 established a Safe Schools Fund and mandates a \$10 million annual appropriation to the fund beginning in FY 2020, which can fund plans for delivery of wraparound/behavioral health services. In July 2018, the administration made \$6 million in school safety grant funding available to school districts through the Safe Schools Fund, as the first installment on a total of \$37.6 million to be awarded. The application period for the first round of grants is open until October 31, 2018. The bill also requires the Commission on Innovation and Excellence in Education to provide recommendations in its final report, due December 31, 2018, on enhanced behavioral health and wraparound services in local school districts as well as funding required for those services. ²

2018 state legislation established the Maryland Prenatal and Infant Care Coordination Services Grant Program to support local jurisdictions, including municipalities, in providing care coordination services to low-income pregnant and postpartum women and to children up to age three. The administration is required to fund the program at \$50,000 annually beginning in FY 2020. DLS projected the fund would likely need at least \$1 million a year to ensure reasonable grant levels for eligible services statewide.³

Another successful bill in the 2018 session created the Maryland Early Literacy Initiative to assist up to 50 Title I schools a year to implement an evidence-based literacy program, primarily targeted to students in prekindergarten through eighth grade. The administration is required to provide at least \$2.5 million annually for grants for qualifying schools.

The U.S. Department of Education published grant solicitations in May 2018 for research studies of certain special education interventions, with applications due March 7, 2019, with projected funding of \$50,000 to \$125,000 over two years. One of the three focus areas of the education research grants is "developmental and school readiness for infants and toddlers with or at risk of a disability;" and the second priority focuses on education outcomes for all students along the cradle to career pathway, including early childhood education.

The <u>Calvert Community Foundation</u> currently funds the Calvert County School Foundation Fund and Partnerships for Youth Success. Charles County Charitable Trust <u>FY 2019 grants</u> totaled \$784,100 to 26 organizations, including \$21,563 to ARC of Southern Maryland; \$60,000 for the Charles County Crisis Hotline; \$30,000 for the Promise Resource Center for the Novo Parenting Program.

The Harry and Jeanette Weinberg Foundation is based in Baltimore, though the Foundation makes grants statewide, including \$25,000 in 2015 to Health Partners in Waldorf. The Zanvyl and Isabel Krieger Fund has a "special initiative (that) focuses on the prevention and treatment of childhood trauma, and supporting parents of very young children from preconception to three years old.".


The Morris and Gwendolyn Cafritz Foundation is based in Washington, D.C., with total grant funding in 2017 of \$18.5 million, with \$7.8 million for community services, \$3.3 million for education and \$2.3 million for health care services. 2016-2017 grants made in Southern Maryland were \$25,000 to Farming 4 Hunger in Prince Frederick. Also based in D.C., The Philip L. Graham Fund provided total 2017 grants of \$3.5 million, with \$65,000 in grants in Southern Maryland: \$35,000 to End Hunger in Calvert, Inc. and \$30,000 to Calvert Hospice, Inc.

Key Findings of the Early Childhood Fund Map

Investments were mostly steady throughout the survey period, increasing by \$1.1 million, or 3.5%, from FY 2013 to FY 2017. The reporting of \$944,035 in BRIDGE grant funding in FY 2017 accounts from most of the increased investments, although the BRIDGE FY 2017 spending was offset by a decrease in WIC spending of \$966,332 from FY 2013 to FY 2017.

Early Childhood investments per child under age 5 grew \$48, or 3.3%, during the fund map survey period.



Key Findings of the Cradle to Career Fund Matrix


After growing \$49.6 million, or 4.2%, from FY 2013 to FY 2015, cradle to career spending went up \$31.8 million, or 2.6%, between FY 2015 and FY 2017, to \$1.25 billion in spending on Southern Maryland children, youth and their families.



With increased spending and declining regional population under age 18, cradle to career spending per child grew \$1,130 through the survey period, an increase of 8.6%.

Education investments, including early childhood education and child care, K-12 education and youth development, accounted for 70.2% of FY 2017 cradle to career spending. Spending on Health (12.5%) and Human Services (13.8%) accounted for about one-quarter (26.3%) of total FY 2017 investments, with Public Safety comprising 3.6% of total spending.



Commercial/Third Party funding are private payers of behavioral health hospital charges. Locally-funded cradle to career spending grew \$40.3 million during the survey period, an increase of 9.6%. Federal funds were up \$32.3 million, or 7.7%, while state funds were basically flat, increasing 1.3%, or \$6.8 million.

The pass-through agency source analysis provides the data to follow the money from the public funder to the community. Spending in local health departments are reported as state agency pass-through spending. Federal agency pass-through spending includes Social Security benefits and federal grants delivered directly to community recipients.

Next Steps: Pending Data Requests


A request for detailed Medicaid somatic health and behavioral health spending from The Institute to the Hilltop Institute remains pending. The Institute is currently awaiting notice of approval from MDH's Institutional Review Board (IRB) which met to consider the IRB application on September 20, 2018, the final step in authorizing the data release. Once the Institute receives IRB approval letter, they can forward to Hilltop Institute for authorized data release of the Medicaid spending. The fund mapping process is currently using estimated Medicaid spending, with caseload data reported on Hilltop Institute's web site and actual Medicaid spending provided for previous versions of cradle to career fund maps in Baltimore City and Prince George's County. The fund maps will be updated with the actual Medicaid data once it is received by The Institute.

A spending request to MDH Developmental Disabilities Administration also is currently pending. See Appendix E – Sources and Methodologies for information on estimating spending items with pending requests. FY 2015 and FY 2017 regional spending data were requested by the Institute from the Department of Juvenile Services; and the request is pending.


A request to Calvert County Health Department and the Charles County Department of Health are currently in process. The Institute also requested detailed behavioral health and special education spending items from the Calvert County Public Schools and St. Mary's Public Schools, which also is currently pending. The Institute will follow up with these agencies with pending data requests and share the draft fund map report to encourage timely response.

Southern Maryland Behavioral Health Fund Map: Fiscal Years 2013, 2015 & 2017

After increasing by \$2.6 million, or 5%, between FY 2013 and FY 2015, behavioral health fund map spending went up by \$7.2 million, or 13.4%, from FY 2015 to FY 2017.



A portion of the relative difference in spending by county can be accounted for by reporting differences in the various fiscal source documents and agency responses. For example, Charles County Public Schools provided detailed Special Education spending for Board Certified Behavioral Health Analyst and Emotional and Behavioral Disorder, while the other school systems detailed Special Education spending was not available.




A \$2.8 million 21st Century Community Learning Center FY 2017 grant for youth mentoring and tutoring to ACF Scholarship Foundation, based in Waldorf, is reported as Charles County behavioral health spending and accounts for much of the Charles County spending increase.

Connecting Investments to Outcomes

Behavioral health investments increased by 13.4% during the survey period; and the number of children placed in residential treatment centers dropped by 7.15, and the number placed in group homes decreased by 29.5%; while the teen birth rate dropped 37.3%.⁴



Behavioral Health Fund Map Spending by Funding Source

Federal funding increased by \$7.2 million, or 68.9%, through the survey period, in part due to about \$3.7 million in two federal grants reported in FY 2017: the BRIDGE grant and 21st Century Community Learning grant to ACF Scholarship Foundation. Local funds were up \$1.5 million, or 12.1%; while state funds dropped slightly, by \$979,636, or 3.7%. The decrease in state funds is mostly due to increased federal Medicaid matching funds, from Affordable Care Act Medicaid

expansion, which was entirely federally funded and began in FY 2014. For the state Medicaid/MCHP budget, the portion of state matching funds dropped from 49.3% in FY 2013 to 38.3% in FY 2017.


In FY 2017, Commercial/third party funding accounted for 6.7% of total spending; local spending made up 22.8% of behavioral health fund map investments; while federal funds accounted for 28.9% and state funds were 41.5% of total spending.



Follow the Money: Behavioral Health Fund Map by Agency Source

Behavioral health fund map spending passed through a county agency increased by 39.5% over the survey period, partly due to the FY 2017 BRIDGE grant, with federal agency pass through spending up due to the \$2.8 million FY 2017 21st Century Community Learning Center grant which was delivered directly to ACF Scholarship Foundation. Spending passed through a state agency increased 15.4%, or \$3.7 million, with behavioral health hospital charges providing \$3.3 million in spending growth. Spending passed through school districts was up \$2.2 million, or 9%, with early childhood special education increasing \$1.2 million.

In FY 2017 combined spending passed-through either a state agency or a school district comprised 89.1% of total behavioral health fund map investments, with 45.4% through a state agency and 43.7% through a school district; while 6.2% of total spending passed through a local agency and 4.7% of total spending passed through a federal agency.


Behavioral Health Hospital Charges for Children and Youth

Behavioral health hospital charges for children and youth under age 20 increased \$3.3 million, or 118%, over the survey period, with \$1.9 million in new spending for Outpatient Psychiatric Acute care reported in FY 2017.


In FY 2017, charges for children aged 10-19 accounted for 97.2% of total charges, with 36.5% of charges for children aged 10-14 and 60.7% of charges for youth aged 15 to 19.

During the survey period, charges for inpatient care increased \$963,774, or 45.6%; while charges for outpatient care jumped 329.7%, mostly related to the \$2 million in new FY 2017 spending on outpatient psychiatric acute care.



Children and Youth Placed in State Psychiatric Facilities


Spending dropped to \$360,844 in FY 2013 from \$880,604 in FY 2013, then increased to \$979,661 in FY 2017.



From FY 2013 to FY 2017, spending was up 86.8% for Calvert County children and youth, 93.1% for Charles County, and 183% for St. Mary's County.

Most charges in each year supported children and youth placed in Spring Grove, with \$444,500 in FY 2013, \$360,844 in FY 2015, and \$632,104 in FY 2017, when there were also \$275,710 spent for children placed at RICA Baltimore and \$71,847 at RICA Montgomery. In FY 2013, there was also \$436,104 spent on children placed at RICA Baltimore.



Opportunities to Supplement Fiscal Strategies in BRIDGE Financing Plan

The Institute prepared a September 2017 <u>BRIDGE Financing Plan</u> with ten detailed finance strategies. Therefore, the "Potential Opportunities" section of the report focuses on updated fiscal strategies and opportunities available after the development of the Financing Plan.

Potential Opportunities: State Funds

School-Based Behavioral Health Funding & Resource Mapping

In the 2018 session, legislation established the Behavioral Health Crisis Response Grant Program to provide funding to local jurisdictions to implement and broaden behavioral health crisis response systems. Beginning in FY 2020, or the next budget submitted, the administration is required to fund the program at \$3 million, with required appropriations increasing to \$4 million in FY 2021 and \$5 million in FY 2022.

The Maryland Safe to Learn Act of 2018 (SB 1265) established a Safe Schools Fund and mandates a \$10 million annual appropriation to the fund beginning in FY 2020. These School Safety Operating Grants can fund security personnel as well as training, community outreach, and plans for delivery of wraparound/behavioral health services. The Fund also retains a \$600,000 special fund annual appropriation, transferred from the School Safety Enforcement Fund, which was subsumed by the Safe Schools Fund, for total ongoing base funding of \$10.6 million. The bill also established a School Safety Subcabinet and Advisory Board, which serves as the governing authority for the Maryland Center for Safe Schools; and included requirements related to school resource officers or law enforcement coverage in or near schools, as well as provisions related to school-based behavioral health services.

In July 2018, the administration made \$6 million in school safety grant funding available to school districts through the Safe Schools Fund, as the first installment on a total of \$37.6 million to be awarded.⁵ The first round of grants includes \$2.5 million for school safety assessments and \$3.5 million for other Maryland Safe to Learn Act requirements, including training for the safety assessment teams, staff and students as well as information sharing mechanisms. The application period for this first installment of grants is open until October 31, 2018.

Effective September 1, 2018, each school district appointed a mental health services coordinator to ensure students referred for behavioral health services receive needed services, maximize external funding for mental health and wraparound services, and develop plans for delivering wraparound and behavioral health services to students. The Subcabinet is required to review the local school system plans by December 1, 2018 and report on gaps in availability of services. The bill also requires the Commission on Innovation and Excellence in Education to provide recommendations in its final report, due December 31, 2018, on enhanced behavioral health and wraparound services in local school districts as well as funding required for those services.⁶

SB 977/HB 1517 of 2018 required the Behavioral Health Administration to report on behavioral health services for children and young adults in the state and required the Social Services Administration to report on voluntary placement agreements. The reports are to be submitted by December 1st of each year. BHA must report on number of children and young adults eligible for services, number treated, total expenditure and spending per child and young adult for specified services, as well as total cost per individual for all services provided. These data will be reported by jurisdiction and by age group.

SB 1 passed in the 2017 legislative session requires each local school system to report on specialized intervention services by December 1, 2018, including data on the number of students in kindergarten through 3rd grade receiving the

services, the grades in which services were provided and the annual spending on services by fund source, i.e., federal, state and local. The local school system and MSDE must post the information on their websites. The bill defines these services to students in these grades who are not currently identified as in need of special education services; need added behavioral health and academic support to succeed; and receive the support in specified settings for at least 90 minutes per week and at least 10 weeks in an academic year.⁷

SB 1060 in 2017 session established a Workgroup on Behavioral and Substance Abuse Programs with Services in the Public Schools in Maryland. The <u>December 2017 workgroup report</u> identified a number of recommendations, including developing a full range of services in all school districts for all grade levels and implementing cooperative agreements between first responders, agencies and school districts to identify and serve students with parental substance abuse or behavioral health issues. A survey of local school districts revealed that 80% of LEAs reported financing and 39% identified adequate space among barriers to expansion of behavioral health services.

An <u>October 2017 MSDE report to the State Board of Education</u> included an inventory of school-wide behavioral health programs as well as practices across the three tiers of interventions.

Maternal and Child Health Opportunities and Funding

SB 912/HB 1685 of 2018 established the Maryland Prenatal and Infant Care Coordination Services Grant Program to support local jurisdictions, including municipalities, providing care coordination services to low-income pregnant and postpartum women and to children up to age three. The administration is required to fund the program at \$50,000 annually beginning in FY 2020. While the required funding is limited to \$50,000 a year, DLS estimated the fund would

likely need to receive at least \$1 million a year to remain viable and ensure reasonable grant levels for eligible services statewide.8

SB 266/HB 716 of 2018 requires the Maryland Health Care Commission, in partnership with several other state agencies and stakeholders, to prepare a report on the mortality rates of African American infants and infants in rural areas.

Early Childhood Education Opportunities and Funding

HB 1415 in 2018 session extended the deadline for the Commission on Innovation and Excellence in Education to complete its work and mandated funding levels for several funds and programs, including the Prekindergarten Expansion Fund. The bill also created the Maryland Early Literacy Initiative to assist up to 50 Title I schools a year to implement an evidence-based literacy program, primarily targeted to students in prekindergarten through eighth grade. The administration is required to provide at least \$2.5 million annually for grants for qualifying schools.

The <u>September 2017 report</u> of the Universal Prekindergarten Workgroup to the Commission on Innovation and Excellence in Education included implementation recommendations and the Workgroup's determination that four-year-old children with IEPs should be considered a priority for full-day prekindergarten slots regardless of household income. In a foreshadowing of a potential recommendation for dedicated state General Funds for preschool special education in the Commission's final report due at the end of this year, the Workgroup also notes that while preschool special education services have been required by state law since 1985, no state General Funds have been allocated specifically to pay for these services; and related IDEA Part B dollars are adequate to pay for just 5% of the cost of the services (see page 20).

Potential Opportunities: Federal Funds

Medicaid Reimbursement for School-Based Behavioral Health Services

In federal fiscal year 2016 states claimed an estimated \$4.5 billion in Medicaid reimbursements for schools, with \$3.3 billion in claims for school-based health services and \$1.2 billion in claims for related administrative activities. Medicaid will reimburse for services provided through an Individualized Education Plan (IEP) or an Individualized Family Service Plan (IFSP) for Infants and Toddlers when certain criteria are met. Medicaid will also reimburse evaluations to identify health-related needs for IEP or IFSP and related administrative activities. Services that are provided through Maryland Healthy Kids/Early and Periodic Screening, Diagnosis and Treatment programs (EPSDT) are also reimbursed through Medicaid.

In federal FY 2016, total Medicaid claims for school-based services and activities in Maryland were \$74.4 million, which represented state and federal match amount, or total funding. The Maryland Medicaid provider manual for school-based health centers (SBHCs) includes a summary of seven steps SBHCs must take to begin the process of billing Medicaid, information on the Eligibility Verification System, billing information and procedures to submit claims to the state and federal governments, and list of covered service categories. The manual also includes information to bill Maryland Healthy Kids/EPSDT and guidance on billing requirements for SBHCs that are sponsored by local health departments.

There are currently SBHCs in half of Maryland's 24 local jurisdictions, with none in Southern Maryland. The FY 2019 SBHC grant application period closed in July 2018. FY 2020 materials should be made available through MSDE's Maryland SBHC Application page.

SAMHSA Grant Opportunities

With a federal budget pending, SAMHSA FY 2019 grant announcements are not currently posted; and would be available through the <u>SAMHSA grants page</u> when posted. Grants with new/competing awards available in FY 2019 for Programs of Regional and National Significance related to Early Childhood Mental Health include Project LAUNCH (18 grants with \$14.2 million in total available awards). A <u>September 2016 SAMHSA report</u> summarizes case studies and findings from many Infant and Early Childhood Mental Health programs funded by Project LAUNCH, with programs across nine categories of interventions, including expanded home visiting programs and family strengthening and parent skills training.

Other SAMHSA grants with FY 2019 new/competing awards available include Healthy Transitions (14 grants with \$15.1 million in available awards); Consumer and Family Network Grants (30 awards with \$3 million available); Mental Health System Transformation and Health Reform (7 grants with \$2.7 million); Youth Suicide Prevention (26 grants with \$18.1 million); Suicide Lifeline (6 grants with \$687,000); and Homelessness Prevention Programs (30 grants with \$9.7 million); Assertive Community Treatment for Individuals with Serious Mental Illness (20 grants with \$13.7 million).

For Children's Mental Health Services, there are 19 new/competing grants with total of \$20.1 million available in FY 2019. Grants with new/competing awards available for Substance Abuse Treatment related to Early Childhood Mental Health include Pregnant and Postpartum Women, which makes grants to states and local jurisdictions to support residential substance abuse treatment and recovery for pregnant and postpartum women, their children and other family members, e.g. father of the children (2 grants with \$1 million in total available awards). Other grants with new awards available in FY 2019 include Children and Families, which funds treatment for youth aged 12 to 25 and their families (8 grants with \$4.5 million); Targeted Capacity Expansion (32 grants with \$8.4 million in available awards; Treatment Systems for Homeless (37 grants with \$8.6 million); Criminal Justice Activities (44 grants with \$13.2 million); and Building Communities of Recovery (7 grants with \$1.5 million). ¹⁰

U.S Department of Education: Special Education Interventions Research Grant Opportunity

The U.S. Department of Education published grant solicitations in May 2018 for research studies of certain special education interventions, with applications due March 7, 2019. With a federal budget pending, the Department projects the grants to be between \$50,000 to \$125,000 with a range of two years. One of the three focus areas of the education research grants is "developmental and school readiness for infants and toddlers with or at risk of a disability;" and the second priority focuses on education outcomes for all students along the cradle to career pathway, including early childhood education.

Opportunity Zones: Long-Term Opportunity to Help Address Space/Capacity Issues

The <u>January 2016 Comprehensive Analysis of Prekindergarten in Maryland</u> identified creating space in the classroom or private marketplace for prekindergarten programs as an ongoing challenge (see page 78). In September 2017, the <u>Universal Prekindergarten Workgroup</u> of the Commission on Innovation reported an additional 6,346 slots would be needed just to maintain current enrollment in a full-day program for all students attending, including a gap of 164 slots in Calvert County, 301 slots in Charles County and 390 slots in St. Mary's County (see page 19). In a recent survey of Maryland school districts, 40% of respondents also identified space as a barrier to expanding school-based behavioral health services.

In the long-term, increased capital investment leveraged through the <u>Opportunity Zones</u> program created by the recent federal Tax Cuts and Jobs Act of 2017 could be a source of funds to address space and capacity issues for both Prekindergarten and behavioral health services. The program offers capital gains tax breaks to attract private

investment into community and economic development projects in low-income communities. The <u>Urban Institute</u> and the <u>Economic Innovation Group</u> offer resources and more information on Opportunity Zones.

Calvert County has three designated Opportunity Zones: Census Tract 24009860703, southwest of Prince Frederick surrounding Barstow and Bowens and the contiguous tracts of Census Tract 24009861003 & Census Tract 24009861004 – the area surrounding Solomons, Dowell, and Lusby. Charles County also has three designated zones, which are Census Tract 24017850202, surrounding Indian Head and the contiguous tracts: Census Tract 24017850709 & Census Tract 24017850802, the east side of Waldorf and surrounding area to east. St. Mary's County has one designated zone: Census Tract 24037876001, the southeast side of California.¹¹

Potential Opportunities: Philanthropic Investments

Southern Maryland & Chesapeake Region Foundations

The <u>Calvert Community Foundation</u> currently funds the Calvert County School Foundation Fund and Partnerships for Youth Success. The Opportunity Fund Grant Program of the <u>Community Foundation of Southern Maryland</u> makes \$5,000 grants to non-profits or government agencies that provide health and wellness services to Charles County residents.

Charles County Charitable Trust FY 2019 grants totaled \$784,100 to 26 organizations, including \$21,563 to ARC of Southern Maryland; \$60,000 for the Charles County Crisis Hotline; \$30,000 for the Promise Resource Center for the Novo Parenting Program; and \$35,000 for domestic violence advocacy and legal representation to the Southern Maryland Center for Family Advocacy; and \$30,000 to United Way of Charles County for planning for a family success center in the Town of Indian Head.

<u>Chesapeake Charities Community Endowment Fund</u> supports child welfare, social services, recreation, health and human services, education, crime prevention and economic and community development. While the group is based on Eastern Shore, the fund will support organizations throughout the Chesapeake Bay region; and they house funds for Southern Maryland partners, including the Calvert County School Foundation Fund and Partnerships for Youth Success.

Baltimore/DC-Based Foundations & The Krieger Fund's Early Childhood Trauma Special Initiative

The Harry and Jeanette Weinberg Foundation is based in Baltimore and focuses much of its Maryland grants on the City of Baltimore; though the Foundation makes grants statewide. ¹² In the most recent <u>report of the Small Grants Program</u> for FY 2015 to FY 2017, there is one grant reported for the Southern Maryland region: \$25,000 in 2015 to Health Partners in Waldorf.

In a 2016 survey of Baltimore philanthropic institutions for the most recent Baltimore City cradle to career fund mapping project, several foundations invested in children's behavioral health across multiple years: The Abell Foundation, The Associated: Jewish Federation of Baltimore; The Jacob and Hilda Blaustein Foundation, The Charles Crane Foundation, The Marion I. and Henry J. Knott Foundation, The Zanvyl and Isabel Krieger Fund, Open Society Institute-Baltimore, and The Harry and Jeannette Weinberg Foundation, The Abell Foundation, The Jacob and Hilda Blaustein Foundation, The Marion I. and Henry J. Knott Foundation, and The Zanvyl and Isabel Krieger Fund have made occasional grants outside of Baltimore City and metro Baltimore.

Behavioral health services constitute two of the four current priorities of The Zanvyl and Isabel Krieger Fund, including a "special initiative (that) focuses on the prevention and treatment of childhood trauma, and supporting parents of very

young children from preconception to three years old," and substance abuse treatment and recovery. The foundation also made robust investments in early childhood education and child care throughout the fund mapping survey period.

The Morris and Gwendolyn Cafritz Foundation is based in Washington, D.C. and supports arts, the environment, education, community services and health care services in the greater metropolitan region. Grant funding in 2017 totaled \$18.5 million, with \$7.8 million for community services, \$3.3 million for education and \$2.3 million for health care services. According to the 2018 annual report, the Foundation has a track record of funding throughout the region, supporting the Chesapeake Bay Funders Network as part of its environmental efforts. 2016-2017 grants made in Southern Maryland were \$25,000 to Farming 4 Hunger in Prince Frederick.

Also based in D.C., The Philip L. Graham Fund supports education, health, human services and arts and humanities throughout the metropolitan region, which is defined as including Southern Maryland. Total grants made in 2017 were \$3.5 million; and \$65,000 in grants made in Southern Maryland that year were awarded in Calvert County: \$35,000 to End Hunger in Calvert, Inc. for capital and heavy equipment needs and \$30,000 to Calvert Hospice, Inc for renovation of its main offices. Like the Harry and Jeanette Weinberg Foundation in Baltimore, the Philip L. Graham Fund focuses on support for capital construction and renovation and maintenance expenses, so these funders may be potential resources in the long-term to lessen space/capacity barriers for prekindergarten and behavioral health programs.

Potential Opportunities: Commercial & Third-Party Funds

Insurance Carriers

SB 858/HB 1132 passed in the 2018 session requires health insurance companies that use a provider panel to ensure all enrollees can access services provided by local health departments, including behavioral health services, if local health departments participate on the carriers' provider panel. Beginning in July 2018, insurance carriers that use a provider panel must file annually a specified network access plan. The Maryland Association of County Health Officers estimates that increased revenues statewide for behavioral health services up to \$1.8 million. Separate legislation prohibits an insurance carrier from putting a cap on the number of behavioral health providers at a health care facility that can become credentialed to participate on a provider panel.


Fee-For-Service

In a 2015 Center for School Mental Health report, a survey of Maryland school systems reported that 15 districts were using fee-for-service charges to partially finance school-based behavioral health services. As the report points out, fee-for-service reimbursement requires a diagnosis and tends to skew towards treatment services but should be included in the mix of funding sources for sustainability. While adding to the financial burden of the region's families is not ideal, child care subsidy income limits recently doubled, so that may provide fiscal relief for any fee-for-service increased costs to working families.


Southern Maryland Early Childhood Fund Map: Fiscal Years 2013, 2015 & 2017

After decreasing by \$1 million, or 3.3% from FY 2013 to FY 2015, FY 2017 early childhood investments increased \$2.1 million, or 7%, from FY 2015, with the FY 2017 BRIDGE grant reporting accounting for about half of this spending growth.



Early Childhood Fund Map Spending by County


The budget for St. Mary's County Public Schools reports salaries for Teachers – Preschool, Prekindergarten and Kindergarten of between \$5 million and \$5.3 million throughout the survey period, which is included in the Early Childhood fund map. The budgets for Calvert and Charles County do not report spending on Early Childhood Education Teachers; and supplemental data requests to the school systems remain pending. In addition, FY 2017 St. Mary's County increased spending items include a \$1.5 million boost in Head Start funding, \$363,000 in increased spending for Infants and Toddlers program and \$165,000 in new funding for a federal Prekindergarten Expansion grant.

Connecting Investments to Outcomes

During the survey period, maternal and child health spending per child under age 5 was down 16.4%. At the same time, maternal and child health indicators all showed worsening outcomes, except for a 21% improvement in the number of regional births to women receiving late or no prenatal care. From FY 2013 to FY 2015, the low-birth weight rate was up 17.4%, the very-low birth weight rate increased 26.7%, and the infant mortality rate spiked by 133.3%. ¹⁴ For school readiness, reporting changes in and after FY 2015 make outcome reporting comparisons difficult, the composite regional score for kindergarteners demonstrating readiness remained unchanged at 44% between FY 2016 and FY 2018. ¹⁵



Early Childhood Fund Map Spending by Fund Source

Like overall early childhood investments, spending was mostly flat for each funding source throughout the survey period. Federal funds increased by \$1.4 million, state funds were down \$26,796, and local funds dropped by \$249,492. In FY 2017, federal funds were 47.4% of total spending, state funds accounted for 30.2%, and local funds paid for 22.4%.



Southern Maryland Cradle to Career Fund Map: Fiscal Years 2013, 2015 and 2017


During the survey period, cradle to career spending increased by \$8.1 million in Calvert County, \$45.9 million in Charles County and \$27.4 million in St. Mary's County.

In FY 2017, education spending, including early education and child care, K-12 education, and youth development accounted for 70% of total regional cradle to career spending; and K-12 education spending is driven primarily by funding formulas depending on student enrollment. Student enrollment dropped in each school district between FY 2013 and FY 2017, with decreases of 2.3% in Calvert, 1% in Charles and 3.4% in St. Mary's.

Although Calvert County saw the largest declines in school enrollment, its enrollment utilization grew relative to the county school age population. In FY 2017, St. Mary's County Public Schools had the lowest percentage of county school-aged children enrolled in public schools at 85.5%, compared to 92.3% in Charles County and 95.9% in Calvert County. The enrollment utilization for St. Mary's declined through the survey period, which partially accounts for the differences in county cradle to career spending per child.



Another primary contributor to cradle to career spending are the entitlements of Medicaid/MCHP. With the Medicaid spending request to MDH/Hilltop Institute currently pending, Medicaid spending is estimated using actual regional Medicaid eligibility data. While all three counties experienced growth in the number of Medicaid-eligible residents after ACA implementation and Medicaid expansion between FY 2013 and FY 2015, growth slowed between FY 2015 and FY 2017. The lagging growth in the number of Medicaid eligibles was particularly pronounced in Calvert County, with caseload growth of just 0.7% between FY 2015 and FY 2017; while the number of eligibles were up 5.2% in Charles County and 5.1% in St. Mary's County over the same time.

Medicaid Spending on Children and Youth

A request to The Hilltop Institute and MDH for detailed Medicaid expenditure data for somatic health and behavioral health is currently pending. The request was recently approved at the September 2018 meeting of the MDH Institutional Review Board and will be processed by The Hilltop Institute as soon as official notice of authorized data release is received from MDH and forwarded by The Institute.

Medicaid and Maryland Children's Health Program (MCHP) spending are estimated with caseload data available through The Hilltop Institute's web site at https://www.hilltopinstitute.org/data/ at Maryland Medicaid eHealth Statistics at https://md-medicaid.org/ and MCHP and cradle to career Medicaid spending data reported by the Department of Health and Mental Hygiene (DHMH) for Baltimore City and Prince George's County for fund maps performed in those jurisdictions.

Maryland Department of Health and Mental Hygiene staff provided actual total FY 2011, FY 2013 and FY 2015 spending on Baltimore City Medicaid enrollees by coverage group. For Prince George's County, actual data was reported for FY 2011 and FY 2013. DHMH staff also provided demographic data for age groups for each coverage group. The cradle to career budget allocated the actual spending for each coverage group by the corresponding actual percentage of enrollees for each age group under age 20.

Maryland Medicaid eHealth Statistics report Medicaid Eligibility data by county and by fiscal year, including the number of total Medicaid-eligible residents for each county by month and average monthly number of Medicaid eligibles for each fiscal year. The total number of annual Medicaid eligibles for Baltimore City for FY 2011, 2013 and 2015 and Prince George's County for FY 2011 and 2013 is compared to the actual Medicaid and MCHP spending and caseload data for those fiscal years reported by MDH. These analyses yield a Medicaid cradle to career and MCHP spending estimate per Medicaid eligible caseload for those jurisdictions in those fiscal years. FY 2015 and FY 2017 Prince George's data are estimated using the percent change between FY 2011 and FY 2013 data.

For the Southern Maryland Medicaid spending estimate, FY 2013, FY 2015 and FY 2017 data on Medicaid eligibles by county are multiplied by the Prince George's County data on cradle to career Medicaid and MCHP spending per Medicaid eligible. Total Medicaid and MCHP estimated spending is allocated to federal and state funds with the actual statewide spending data by funding source reported in the state budget. Medicaid behavioral health spending is estimated with recent data from the Stark County, Ohio fund map, where behavioral health services accounted for 11.8% of total Medicaid spending on average across the four years of the survey period. Therefore, 11.8% of total Medicaid estimated spending for federal and state funds are projected to be behavioral health spending.

Maryland Department of Health

Maryland Department of Health (MDH) Health Services Cost Review Commission (HSCRC) provided behavioral health hospital charges for residents under age 19 by rate center, by diagnosis, by zip code and by expected payer. Hospitals code the payer at the time of service, when the eventual payer is not known; and they do not report the eventual, actual

payer to HSCRC. Behavioral health charges with an expected payer of Medicaid are assumed to be included in Medicaid payments data to be reported by the Hilltop Institute and the Maryland Department of Health. According to HSCRC staff, there were no Neonatal Intensive Care Unit charges in the region in either FY 2013, FY 2015 or FY 2017.

MDH Behavioral Health Administration staff provided FYs 2013, 2015 and 2017 spending by funding source on regional residents under the age of 20 by county that are placed in State Psychiatric Centers. DHMH Prevention and Health Promotion Administration provided check reimbursements for regional residents by county through the entirely federally funded Women, Infants and Children (WIC) program.

A request to DHMH Developmental Disabilities Administration staff for spending on regional residents under age 20 in the State Intellectual Disability Centers and for community services provided to residents under the age of 19 remains pending. These investments were estimated with actual data on community services spending for Baltimore City residents under age 19 provided by DDA staff. These data were used to calculate DDA community services spending per Baltimore City resident under age 18, which was used with regional Census data on number of residents under age 18 in each county to calculate DDA community services spending for each county.

Local Health Departments

St. Mary's County Health Department provided FY 2013, FY 2015 and FY 2017 spending by Division, as well as spending on the following items: Maternal and Child Health, Developmental Disabilities, Infants and Toddlers, Family Planning Services, and School Health. These detailed spending items are included entirely in the fund map and are factored out of the spending reported for Health Promotion and Community Services. Remaining spending on Health Promotion and Community Services as well as other reported agency spending are allocated to the fund map with the percent of County residents under age 18.

Requests to the Calvert County Health Department and the Charles County Department of Health remain pending. The Department of Legislative Services (DLS), Office of Policy Analysis staff provided local public health financial data for each Maryland county, including State Core Public Health Funding, as well as Local Health – Non- Budgeted Fund Expenditure by state and local funding source. For St. Mary's County, the data reported by DLS for State Core Public Health Funding corresponded to the Core Services spending item reported by the Health Department. And the DLS-reported total Non-Budgeted Fund Expenditure correlated to the total agency spending reported by the Health Department.

While the requests to Calvert and Charles counties remain pending, the fund map uses the Core Public Health and total Non-Budgeted Fund Expenditure reported by DLS for each county to estimate agency spending. To avoid double-counting in the fund map, DLS-reported expenditures on Core Public Health are factored out and reported separately from total Non-Budgeted Fund Expenditures. All estimated spending for the Calvert County Health Department and the Charles County Department of Health is allocated to the fund map with the percent of County residents under the age of 18. For each county, Core Services/Core Public Health spending is assumed to Behavioral Health administrative.

Maryland Department of Human Service/Departments of Social Services

Maryland Department of Human Services fiscal staff provided FY 2013, FY 2015 and FY 2017 actual spending by funding source for Family Investment, Child Support and Child Welfare programs for each county. The programs are listed below.

Maryland Department of Juvenile Services

Actual spending by subprogram for FY 2013 and for the FY 2015 allowance were provided by the Department of Juvenile Services (DJS) for each county statewide for previous fund maps. A request for FY 2015 and FY 2017 actual spending for Southern Maryland to DJS remains pending. FY 2015 DJS spending by subprogram is estimated with the change from the original FY 2015 allowance to the FY 2015 actual spending data reported in the FY 2017 state budget. FY 2017 spending is estimated with the spending change between the FY 2015 actuals and FY 2017 actuals reported in the FY 2019 budget. Total spending is allocated between state and federal funds with the percent of state and federal funds in the actual spending data in each state budget.

Maryland Office of the Public Defender

Actual spending by funding source data are from the state budget, which are allocated to cradle to career fund map with census data on the percent of population under age 18 for each county.

Governor's Office of Crime Control and Prevention: State Aid for Police Protection Fund

Actual spending by funding source data are from the state budget, which are allocated to cradle to career fund map with census data on the percent of population under age 18 for each county.

Maryland State Department of Education (MSDE)

See public schools' section in local-level agency sources below for data sources on state spending in local school systems.

MSDE Division of Early Childhood Development staff reported FY 2013, FY 2015 and FY 2017 spending on Early Head Start, Head Start – State Supplemental Funding, Prekindergarten Expansion, Early Childhood Mental Health: Southern Maryland Project First Choice, Judy Hoyer Centers, and Child Care Subsidies.

State expenditures on Judy Hoyer Centers and Head Start are also reported in the budgets for the respective school systems. As the data were reported more recently, the fund map uses the spending amounts reported by MSDE rather than the local school system budgets. The FY 2019 budget for St. Mary's County Public Schools reports \$146,880 in restricted fund revenue as a federal preschool development grant, while MSDE reported \$165,000 in FY 2017 federal

spending for prekindergarten expansion. The fund map assumes these two spending items are reporting the same grant and uses the amount reported by MSDE.

Actual expenditures by funding source for the Maryland School for the Deaf, Maryland School for the Blind, Blind Industries and Services of Maryland, Aid to Nonpublic Schools, and Juvenile Services Education Program are reported in the Maryland Operating Budget in various places in the MSDE section, except for School for the Deaf which is reported at end of higher education section. Statewide spending was allocated for each county to the cradle to career fund map with the percent of statewide population under age 18 living in each county. For example, in FY 2013 the state population under age 18 was 1,348,047; and Calvert County had 22,377 residents under age 18, or 1.7% of statewide total.

MSDE Funding for Educational Organizations includes grants to Calvert Marine Museum and Sotterley Foundation, which are allocated to the cradle to career fund map for Calvert and Charles County respectively with the percent of county population under age 18.

State spending on the State Share of Teachers' Retirement is reported in the <u>"Selected Financial Data Maryland Public Schools Ten Year Summary"</u> reports for each school year in Part 2 Expenditures of the report. See the Fixed Charges tab called "fxchrg" in the last column. Note: This spending item was not included in the Baltimore City or Prince George's County cradle to career fund maps. Spending on State Share of Teachers' Retirement would be added into any updated versions of those fund maps.

The MSDE Selected Financial Data Ten Year Summary documents report spending on Adult Education and related Fixed Charges. See Part 2 and the Adult tab. This spending is not included in the fund map.

Local Management Boards

Local Management Board staff provided data on their FY 2013, FY 2015 and FY 2017 contracts. The information provided included the organization, program, funding amount, agency source, and purpose of the grant.

Governor's Office for Children

Actual spending data for the Governor's Office for Children from the Maryland Operating Budget, are allocated to the fund map for each county with the percent of Maryland residents under age 18 living in each county.

Local-level Agency Spending

Local Education Agencies

For each school system's budget, the timing of reporting actual spending is the same as the state budget: FY 2013 actuals are reported in the FY 2015 budget; FY 2015 actuals are reported in the FY 2017 budget; and FY 2017 actuals are reported in the FY 2019 budget. The cradle to career fund map does not include capital expenditures, so Capital Outlay spending is not included.

The MSDE Selected Financial Data Ten Year Summary documents report spending on Adult Education and related Fixed Charges. See Part 2 and the Adult tab. This spending is not included in the fund map.

Calvert County Public Schools

The Operating Budgets are available at

The budget reports detailed data on revenue, including revenue by funding source, and spending for both the Unrestricted Fund and the Restricted Fund. The budgets report spending for both fund by the following categories: Administration; Mid-Level Administration; Instruction; Special Education; Student Services, Health Services, Student Transportation, Operation of Plant, Maintenance of Plan, Fixed Charges and Capital Outlay.

For the Unrestricted Fund, the budgets report detailed spending on Guidance Counselors and School Psychologists under the Instructional Salaries and Wages subcategory; and Guidance Supplies are reported under Instructional Supplies subcategory. Expenditures on Contracted Psychologists are reported in the budgets under the Other Instructional Costs subcategory. Spending on these detailed behavioral health items are reported in the fund map and factored out of spending in the appropriate subcategory.

In the Restricted Fund, the number of school psychologist positions funded is reported, while spending on these positions is not reported. Using the staff cost per school psychologist reported in the Unrestricted Fund, spending on school psychologists from the Restricted Fund is estimated, reported in the fund map, and factored out of Instruction spending.

The budget for the Restricted Fund reports revenue by fund source, with detailed reporting on the federal, state or local program, or funding stream, supplying the revenue, e.g., Race to the Top, IDEA Special Education Part B - Preschool or Part C — Early Intervention. The fund map reports detailed revenue items for Home Visiting, Early Childhood Education and Early Childhood Special Education as spending items and factors them out of the reporting of Instruction and Special Education spending respectively.

FY 2015 revenue in the Restricted Fund reported as the Calvert County Family Network Bullying Prevention Program is included in the fund map and factored out of Restricted Fund Instruction spending.

State funding for Judy Hoyer Centers and State Supplemental Funding for Head Start are reported in the school system budgets. MSDE Division of Early Childhood Development staff reported these data in September 2018; and the MSDE data are used as most recent.

Spending items in both the Unrestricted Fund and Restricted Fund are allocated by funding source, i.e., federal, state and local sources, with the percent of total funding for each funding source in the Unrestricted and Restricted Funds respectively.

Commercial/Third Party Spending

MDH Health Services Cost Review Commission (HSCRC) provided behavioral health hospital charges for residents under age 19 by rate center, by diagnosis, by zip code and by expected payer. The reported payers in the HSCRC data are Charity/Self Pay, Commercial, Medicaid and Other. Hospitals code the payer at the time of service, when the eventual payer is not known; and they do not report the eventual, actual payer to HSCRC. Commercial/third party spending are charges with anticipated payers of Charity/Self Pay, Commercial and Other. Behavioral health charges with an expected payer of Medicaid are assumed to be included in Medicaid payments data to be reported by the Hilltop Institute and the Maryland Department of Health. According to HSCRC staff, there were no Neonatal Intensive Care Unit charges in the region in either FY 2013, FY 2015 or FY 2017.
